

Course Description

Do you know your rights? The course provides the student with foundational information about the U.S. legal system, dispute resolution, and their impact on business. Business Law focuses on an understanding of the judicial system at the local, state, and national level. Topics include a general understanding of constitutional law, torts, ethics, rights and responsibilities as citizens, utilization of financial transactions, employment, and agency relationships.

We will be utilizing several different software programs, hands on projects, online assignments, assessments, and semester end projects.
